# 7. Individual tasks

An individual task has the object of making deeper, summarizing and consolidating knowledge which students have gained from lectures. It carries out as a student research paper. Choosing a topic of the research paper is made by each student individually.

When a student prepares the research paper, he/she needs to follow assumptions of its presentation:

- the task can be typing or written by hand (legible and neat handwriting) on the paper sheets of A4 format;
- typing should be made by font "Times New Roman", size 14, line spacing 1,5, page numeration on the right high corner.
   Margins: head and bottom 2 cm, right 3 cm, left 1 cm;
- it is necessary to specify on the title page: a name of the individual task, speciality, a student's surname and initials, an academic group and the training course name (Appendix A);
- it should be added a bibliography, data and a student's signature at the end of synopsis.
